2. Review of Minutes from previous meeting

The CACG resolved that the minutes from the previous meeting of the Camden Airport CACG held on 26 May 2022 be adopted.

Daniel Jarosch, Aeria Management Group (AMG) CEO noted the slide presentation (attached to these minutes) are an important communication tool for the community – and will be distributed publicly by AMG, primarily via the AMG website.

3. CACG Chair and membership

Daniel Jarosch advised that the position of Chair and membership of the CACG is being further reviewed and an update will be provided at the next meeting.

4. AMG Airport Update

AMG tabled the Community Briefing information and provided an overview of the contents with general discussion by the CACG.

The following matters were discussed:

- New members & attendees at future CACGs:
 - Local community
- Flooding and Stormwater Management:
 - o Stage 1 drainage works in Northwest completed.
 - o In progress Repairs and maintenance of swales (60% complete), Stage 2 major package stormwater upgrades and carpark repair
 - Action AMG to consult with on-airport residents for flood and stormwater solutions impacting on their properties.
 - o Further information was sought by on-airport residents on the repair to the bridge on Macquarie Grove Road which is limiting traffic movements.
 - Action Council to provide update to future CACACG when available
- Infrastructure Master Planning:
 - o Infrastructure master planning ongoing across pavements and utilities.
 - Action AMG to consider height of electricity wires on Aerodrome Road which are impinging on movement of trucks.
 - Tenants installing wireless internet access due to lack of NBN to premises, and this is performing well.
 - Action AMG to further consider NBN to premises.
 - o On-airport residents noted lack of lighting at night and experiencing vehicles coming and going at night at speed. AMG noted informal regular police patrols in progress.

- Action AMG to consider lighting (including sensor lights) and formal security arrangements (including CCTV).
- Action AMG to consider re-introduction of speed limitation devices on Aerodrome Road (e.g. speed bumps) as part of traffic management plan
- Fencing Upgrade Project:
 - New airside fence will be installed to improve vehicle and pedestrian airside access controls, wildlife incursion control and security
 - Action AMG to consult with on-airport residents on fencing solutions with potential impact on their properties.
- Growth Opportunities Airport Business Zone
 - o General discussion in relation to potential development opportunities in the Airport Business Zone. AMG noted that the focus is on the existing aviation zone and growth in aviation businesses. On Airport residents noted the unique history of the airport and the desire to retain the heritage and aviation focus.
- Ex-Gratia Land Tax
 - Action AMG to send updated communication to Tenants.
 - Action AMG to seek feedback from the Department on their EGLT timetable to quantify the impact on tenants.

5. AMG New Brand Update and New Signage / Wayfinding for Camden Airport

Daniel Jarosch noted that the name of Syndey Metro Airports will change to AERIA Management Group and that AERIA will be the new name for the entire precinct (313 hectares) at Bankstown, and will continue to be the home of Bankstown Airport. This includes new brand identities for Bankstown Airport and Camden Airport. The program includes a soft launch Nov / Dec 2022, and an official launch event Mar / Apr 2023 – with new signage and wayfinding 022/23+.

Daniel Jarosch was emphasised that the name of Camden Airport and Bankstown Airport will not change.

 Action – AMG to ensure acknowledgements to heritage of the Airport on airport entry statements and wayfinding signage.

6. DITRDC Update

Jake Sullivan (Department) and Michael Robbie (Department) provided the following update (a copy of the presentation is attached to these minutes):

- Following the recent Federal election and the change in Government, there is a the new Secretary and updated Portfolio Organisation Chart.
- The September Federal Government Jobs Summit was discussed, including topics from the Aviation roundtable.
 - General discussion from tenants relating to the difficulty in finding and retaining skilled works including engineers.
- The new Government has committed to the preparation of an Aviation White Paper (which will be subject to future consultation).
- Other Aviation industry themes presented included:
 - o Sustainability
 - o Women in Aviation and Workforce skills (funding extended to 2024-25).
- The Department is seeking feedback on the Sunsetting Regulations Stage 2, with key stakeholders notified and invited to provide written submissions on the discussion paper before 19 October 2022

- PFAS Pilot Program (Bankstown Airport is participating) was discussed.
- National Airports Safeguarding Group (NASAG) was noted as likely to feature as a more regular update at future CACGs – in particular Land Use Planning around Airports.
