5. PolAir Update

Simon provided a presentation on behalf of PolAir:

- Policing is a 24/7 operation; training is a part of BAU.
- Acknowledging this creates noise for local residents program is constantly under review.
- BA responsible for Rescue Squad & Drug Squad (statewide); body of training is extensive
- Collaborate with Army (Holsworthy) and Camden for alternate locations to winch; still have an underlying need to
 use western grass (Georges Hall)
- ASA offered to provide times / locations for PolAir to plan around.

David McMahon provided an update via Microsoft Teams:

- Green Paper scheduled to be released mid-2023. Round tables to follow.
- Aviation White Paper scheduled first half of 2024.
- PFAS Pilot Program (Bankstown Airport is participating) was discussed. No material items to note given Bankstown is involved in the Pilot Program; expected to conclude EOFY.
- National Airports Safeguarding Group (NASAG) was noted as likely to feature as a more regular update at future CACGs in particular Land Use Planning around Airports. Next Meeting 19 April.

- Paul Argent introduced as Nik Wahi's replacement.
