Sustainability initiatives

- First Sustainability Report in Q4 CY2023 reporting achievements against our sustainability areas of focus
 - AMG emissions inventory Scope 1, 2 and 3 by Q4 CY2023
- Sustainability highlights:
 - Expanding solar to 6MW over 2023/24
 - Investigating solar battery options
 - All new buildings to obtain Greenstar ratings (currently two with 4 Star, nine with 5 Star)
 - 8 x EV charging stations installed at 361 Milperra Rd, 430 Marion St and Airport Ave café carpark
 - Nil environmental incidents, fines or prosecutions
- Partnering with tenants to reduce emissions and assemble data

Sustainability - Environment

- Bush regeneration Hibbertia *
 - Maintenance program ongoing
 - Regrowth identified post flood damage
- Per and polyfluoroalkyl substances (PFAS)
 - Commonwealth Government's PFAS Investigation Pilot Program:
 - Preliminary Site Investigation (PSI) finalised
 - Detailed Site Investigation (DSI) anticipated to commence Q3/Q4 CY2023

Aviation activity

• Aircraft movements

- CY2022:
 - 226,616 movements
 - 16% below 2019 levels (pre-Covid)
 - 13% below Master Plan forecast of 240,000
- Six months to June 2023:
 - 117,816 movements
 - 3.8% above pre-Covid levels


- 23% below Master Plan forecast of 152,976

- March to August 2023: 15 complaints (from 5 complainants)

Aviation pavement repairs and maintenance


- Line marking refresh continuing





Aviation development – opportunities

- Aviation leasing opportunities:
 - Information Memorandum available: <u>https://aeria.co/wp-</u> content/uploads/2023/08/Aeria-IM-A4-AUGUST-2023-WEB-3.pdf
- Aviation "Supersite" (Opportunity A)*
 - Proposed world-class aviation facility, supporting next generation of General Aviation users
 - Aviation safety assessment positive
 - Planning for Draft MDP release by early 2024
- Aviation Infill Sites (Opportunity B to F)*
 - Site investigation and safety assessment underway
 - Conceptual designs completed
 - Marketing program and initial discussions with aviation operators

Airside pavements upgrade

- Essential works to enhance safety, amenity and conditions of airfield pavements
- Four community information sessions held prior to works commencement
- Stage A works commenced August 2023 partial closure of Taxiway Alpha and Northern Runway
- Works staged to minimise disruption and Phase 1 due to complete in April 2024

Western Sydney International Airport

Section 3.0 Non-Aviation

Tower Road upgrade

- Major upgrade of Tower and Link roads to improve condition, alignment, amenity, safety and security
- Community information sessions held prior to works commencement
- Stage 1 works commenced July 2023 traffic management measures in place
- Works staged to minimise disruption. Stage 1 to complete in October 2023
- Total works ~5% completed
- Program completion by Q3 24

Aeria precinct upgrades & management

- Airport Avenue Re-sheeting completed June 2023
- Intersection upgrades:
 - Henry Lawson Drive works underway by TfNSW
 - Milperra Road / Murray Jones Drive intersection upgrade due to start in Q4 CY2023
- Building 62:
 - Vacant since 2005 and unsafe for occupation or use
 - Barrier hoarding erected for safety of airport users and visitors
 - Photographic Archival Report completed
 - Heritage Interpretation Strategy completed
 - AMG in consultation with RAAF on future of site




Aeria Utilities

- Market pricing pressure continues
- NSW Govt \$650 energy cost relief for small business (<u>further detail</u>)
- Solar array installations:
 - Planned 6MW installations ~10% complete
 - 4.8MW commenced and to complete by Q4 CY2024
- Battery storage:
 - Sites identified and technical feasibility underway
 - Battery sites now identified in HV Masterplan
- HV Network resilience:
 - Substations 2 & 16 replaced
 - Infrastructure upgrades commenced May 2023
 - Further upgrades of five substations over CY2023/24



Development – delivery

- Industrial Warehouses (south precinct):
 - Building 4C (DHL) Completed June 2023
 - Building 4B Completed and leased by August 2023
 - 343 Milperra Rd (Industrie Clothing) Completed and open in August 2023
 - Landcross warehouses (behind Bunnings) construction ongoing (non-AMG development)
- Industrial Units (430 Marion St):
 - Stage 1 (6 units) now completed and fully leased
 - Stage 2 (1 unit) due for completion September 2023



Development – planning

- Birdwood Road Precinct:
 - Potential Mixed-Use development *
 - Retail shops fronting Birdwood Rd
 - Industrial / office units fronting Tower Rd
 - Draft MDP to be submitted by Q1 CY2024
 - Community consultation process
- **Southwest Precinct** (Starkie Drive):
 - Conceptual design includes industrial units and retail amenity *
 - Feasibility studies ongoing by AMG
 - Planning timeframe circa 12 months
