5. DITRDC Update

Nik Wahi provided the following update:

- Following the recent Federal election and the change in Government, no detailed update is provided. The responsible Minister and government portfolio arrangements will be finalised shortly
- The Department acknowledged the challenges faced by the aviation industry as a result of Covid
 with lower freight supply, no international travel and illness and isolation requirements affecting
 the workforce. Late last year, the Aviation Recovery Framework was released focusing on six
 strategic priorities:
 - Adjusting Regulatory Investment Settings
 - Building a Core Workforce with Skills for the Future
 - Adopting and Intergrading emerging Aviation Technology
 - Modernising Regulation
 - o Highlighting the Important Role of General Aviation
 - o Providing Targeted Support for the Regional Aviation Industry
- The new Government has committed to the preparation of an Aviation White Paper (which will be subject to future consultation)
- The Department is seeking feedback on the Sunsetting Regulations Stage 1A and 1B with key stakeholders notified and invited to provide written submissions on the discussion paper before 3 June 2022
- PFAS is getting more prominence a PFAS Pilot Program is underway
- Next meeting of the National Airports Safeguarding Group (NASAG) to discuss the National Airport Safeguarding Frameworkis scheduled for 16 June 2022 (in Adelaide)
- Nik Wahi expressed his appreciation for the recent opportunity to visit Bankstown Airport and to meet tenants

7. Canterbury Bankstown Council Update

Camille Lattouf provided the following update:

- Draft LEP is currently in the system expecting to be finalised by late 2022 (seeks to increase residential density)
- Bankstown Master Plan has been adopted, commencing the rezoning process exhibition (heights up to 24 storeys are proposed at the Metro Station)
- Joint Collaboration continuing:
 - o Health
 - Transport Strategy (potential for rapid bus)
 - Bankstown-Liverpool Connection CACG discussed the possible transport link with Bankstown Airport
 - Metro (opening up to Sydenham in 2023 future expansion in 2024)
- Metro scheduled for 2024 is currently under construction
- Hospital announcement is imminent
- University due for opening in 2023
- CACG discussed the potential to connect business investment from Council with SMA
