Sustainability

- **Leadership in sustainability**
 - Awarded 5 Star Green Star rating for Altitude Premier Logistics Precinct - Warehouse 1 (Beijer Ref and Hellman Logistics)
 - Continued expansion of solar power
 - By end-2024: Renewables to power 100% of AMG's Bankstown Airport operations and 30% of customers' electricity needs across Aeria
 - Investigating battery storage to continue transition to net zero
 - Commissioning EV chargers across the Aeria precinct
- **Environmental management**
 - Nil environmental incidents, fines or regulatory action.
 - Managing pavement and road projects in full compliance with environmental best practice
 - Participating in the DITRDCA PFAS investigation program
- **First public AMG Sustainability Report**
 - Will include details of Scope 1, 2 and 3 emissions
 - Sustainability pillars, targets and KPIs

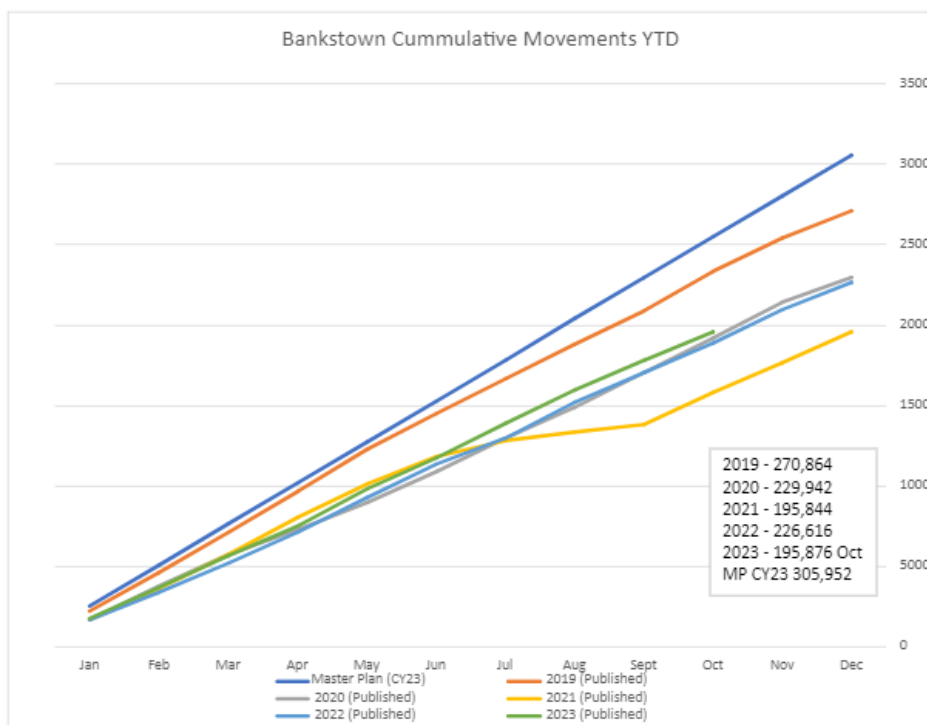
Aviation activity

• Aircraft movements

- Bankstown Airport CY2022 (total): 226,616 movements
 - 16% above pcp CY2021
 - 16% below 2019 levels (pre-Covid)
- Bankstown Airport CY2023 to October: 195,876 movements
 - 24% above pcp CY2021 to October
 - 16% below 2019 levels (pre-Covid)
 - 23% below Master Plan forecast of 254,960
- Camden Airport CY2022 (total): 87,228 movements
 - 9% below pcp CY2021
 - 12% below 2019 levels (pre-Covid)
- Camden Airport CY2023 to October: 79,994 movements
 - 2% below pcp CY2021 to October
 - 6% below 2019 levels (pre-Covid)
 - 12% below Master Plan forecast of 90,910

• Noise Complaints to AMG

- 3 months to Nov 2023:
 - Bankstown Airport: 13 complaints (5 complainants)
 - Includes emergency helicopters and overnight aircraft flights
 - Camden Airport: 2 complaints (2 complainants)
 - Relates to CT4 aircraft operations



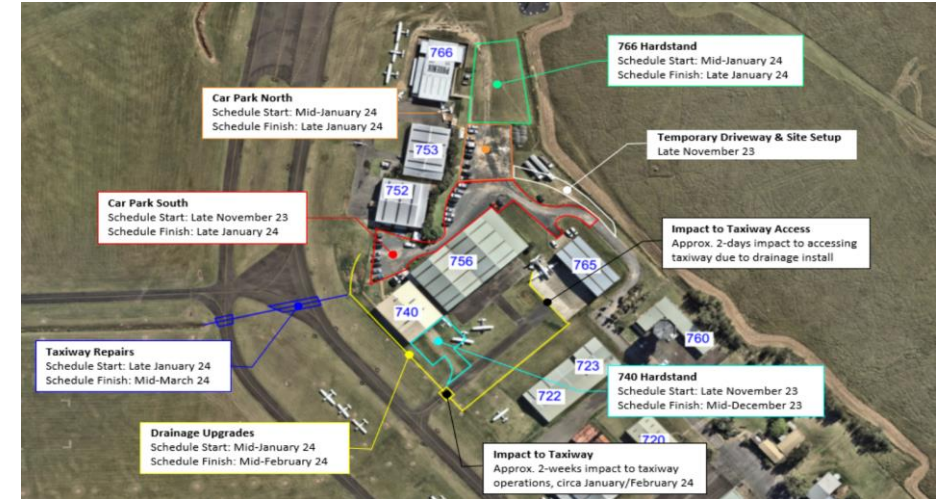
Aviation upgrades

Camden Airport

- Carpark and stormwater infrastructure upgrades commenced (Nov 2023), including enhancements to airside aprons and taxiway
- Updates: aeria.co/news/camden-car-park-and-stormwater-upgrades/
- Installation of perimeter fencing (c. 3km) and electric access – controlled airside gates
- Rolling out new signage and wayfinding
- Undergrounding electrical overhead lines to enhance safety

Bankstown Airport

- Continuing major airside pavements upgrade
 - Works staged to minimise disruption
 - Ongoing regular consultation meetings with customers
 - Stage A completed
 - Stages B & C commenced Oct 2023
 - Updates: aeria.co/news/airside-pavements-upgrade/

Non-aviation and developments

Upgrades and Project Updates

- **Tower/Link Road upgrade** – Improved condition, alignment, amenity, safety and security
 - Nov 2023: Start of Stages 7-10 and night works, to minimise inconvenience to road users
 - Updates: aeria.co/news/exciting-upgrades-to-tower-road/
- **Intersection upgrades**
 - Henry Lawson Drive works underway by TfNSW
 - Milperra Rd/Murray Jones Drive upgrade to start in 2024
- **Altitude Premier Logistics Estate & 430 Marion st Industrial Warehouses** – both now reached final practical completion and fully leased
- **Georges River Grammar** – Assembly hall application approved and construction to commence imminently
- **Aeria Utilities energy network**
 - Ongoing infrastructure/substation upgrades
 - Ongoing expansion of solar panels
 - Investigating battery storage to continue towards net zero



New Major Development Plans 2024

New Aviation precinct

- Up to nine new hangars with flexible offices, and direct aircraft access
- For operations such as emergency services, aircraft charter, maintenance, flight training or Advanced Air Mobility
- Site is north-east of Bankstown Airport aviation zone, with proposed link via Avro Street

Birdwood Road – community, retail and office hub

- New centre for residents, families and businesses, planned to include:
 - Retail and community facilities, including childcare centre and/or indoor recreation centre
 - Office suites, including potential health facilities
 - Small warehouse units

Aviation White Paper / Green Paper

Opportunities for general aviation airports

- Emerging aviation technologies – Evolution towards Advanced Air Mobility (AAM) aircraft, including electric/hydrogen and drones
- Transition to net zero – Sustainability initiatives and AAM
- Flight training – Growing global demand for pilots, aligned with transition towards electric/hydrogen aircraft
- Community consultation – Building engagement and consultation

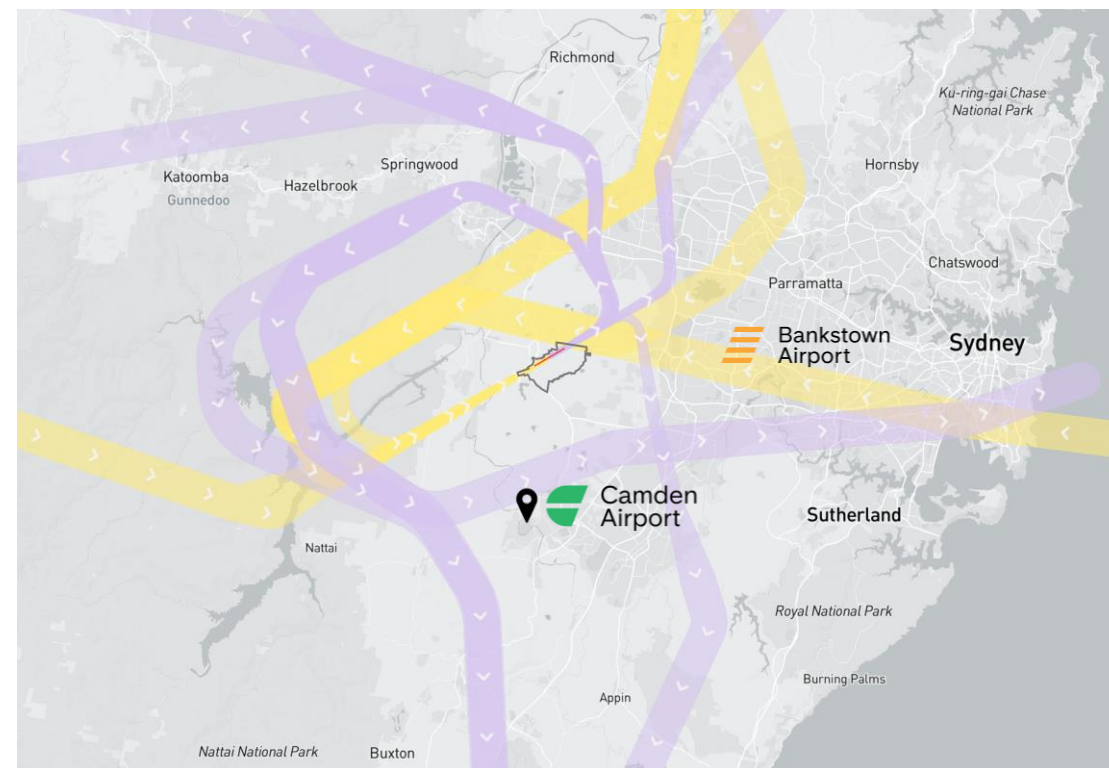
AMG submission to Green Paper (lodged 30 Nov 2023) – calling for:

- Aviation Innovation Infrastructure Fund to enable emerging technologies
- Aviation Innovation Fund for development/adoption of emerging technologies
- Development approval exemptions/streamlining for innovation projects
- Airspace review for Greater Sydney to support flight training and AAM aircraft
- Increased community information/education about aircraft noise
- Alignment of training and qualification pathways for pilots and engineers
- Fee-free study for emerging aviation technology upskilling

Western Sydney International Airport – advocating for AMG airport operators

- Draft Environmental Impact Statement released by Department Oct 2023
- Airspace and flight path changes will have significant impacts:
 - WSI-controlled airspace and congested flight paths may increase response times for Emergency Services and safety risks/hazards for General Aviation.
 - Increased flight training times, schedules and costs
 - Draft EIS estimated cost of \$15m p.a. – substantially understates operational and business costs
- AMG advocating for government support for flight training amid growing global workforce shortage, such as:
 - Incentives to transition to electric/hydrogen aircraft
 - Funding for potential expansion of operations at Camden Airport
- CASA technical briefing with flight schools on 30 Nov 2023 – likely to see redrawing of proposed new training areas and refinement of proposed Engadine Corridor
- EIS submissions due 31 Jan: infrastructure.gov.au/have-your-say/draft-environmental-impact-statement-western-sydney-international-nancy-bird-walton-airport
