#### AMG news

- Appointment of AMG CEO Tom Smith
- Appointment of AMG COO Amanda Majarres
- <u>July 2024</u>: AMG partners with AMSL Aero to introduce hydrogen as an aviation fuel at Bankstown Airport
  - Hydrogen fuel to extend the range of AMSL's Vertiia Vertical Take-Off and Landing (VTOL) aircraft from 300km to 1000km
  - Breakthrough will make Vertiia the longest-range passenger-capable VTOL aircraft in the world
- <u>October 2024</u>: Updated Conditions of Use for Camden Airport to govern use of airport facilities and services, including operational requirements and aviation charges



#### Section 3.0 Aviation operations and upgrades

#### Aircraft movements

- Camden Airport 2024 Financial Year (FY) totals\*
  - o 88,672 aircraft movements
  - 4% decrease in movements compared with 2023FY
  - Contributes 6.77% of total national network aircraft movements
- FY 2025 cumulative total (as at September 2024)
  - o 23,562 aircraft movements
  - $\circ~~$  90% of FY 2024 count for the same period
  - Average 584 helicopter movements per month
  - 100% aircraft have Maximum Take Off Weight (MTOW) of less than 7 tonnes

# Car park and stormwater upgrades

- Major upgrade completed successfully in May 2024, improving airport safety, accessibility, amenity and resilience of operations, infrastructure and facilities to flooding and major weather events
- Completed works included:
  - Upgrade of stormwater system to improve water drainage away from operating areas and reduce impact of flooding events
  - Reconstruction and resurfacing of airport car park
  - Upgrade of car park access road
  - Upgrades to aprons, hardstand and hangar access
  - Widening of taxiway to improve safety for turning aircraft
- Works staged from late 2023 to May 2024 to minimise disruptions availability of car parking maintained at all times
- Efficient delivery of works enabled early reopening of Taxiway Delta and Taxiway Charlie











### Fencing upgrade – Stage 2

- Works to start shortly on major fencing upgrade at Camden Airport
  to improve security, wildlife barriers and operations
- Works will build on recent installation of new perimeter fencing and access-controlled airside gates at Camden Airport
- Works scheduled from mid-November to end December 2024, including:
  - Installation between airport hangars of 1.8m chain wire fence and pedestrian gates with keypad access
  - Upgrade to triangular perimeter fence around northern helipad, to further reduce wildlife disruptions
  - Locked vehicle access gates to improve security AMG to provide keys to customers (subject to required airside permits)
- AMG will work with customers to minimise inconvenience and disruptions



#### Fuel relocation and hangar works

- Relocation of airport fuel site works expected to commence in Q1 2025
- Relocation will unlock new c. 1000sqm hangar for lease (Site 742)
- Works will include establishment of new taxiway approach
- Hangar construction to commence after completion of relocation works expected c. Q3 2025

#### Section 4.0 Other developments

#### **Aviation Hangar Project MDP**

- Proposed construction of two aircraft hangar buildings at Bankstown Airport for up to 10 separate general aviation operations – with associated offices, car parking, hangar aprons and open aircraft parking
- Project site in the heart of the airport aviation zone
- Flexible design will cater for diverse operations, such as emergency services, flight training and emerging electric- and hydrogen-powered aircraft
- Project consistent with Bankstown Airport Master Plan 2019 and AMG Sustainability Framework
- Preliminary Draft MDP on public exhibition to 3 Feb 2025

### **Aviation White Paper**


- Commonwealth Government Aviation White Paper (released August 2024) designed to guide policy and initiatives for Australian aviation sector to 2050
- Highlights include:
  - Government affirms commitment to "strong and diverse" general aviation (GA) sector
  - Government affirms essential role of GA as "ideal testing ground" for "next generation aircraft"
  - Extended subsidies for ADS-B equipment
  - R&D funding for emerging net zero aircraft
  - Reforms to training pathways for licensed aircraft maintenance engineers
  - o Upcoming review of CACG guidelines
  - Additional infrastructure funding for regional airports
  - Airport Master Plans and Major Development Plans to address: appropriate community consultation; access/space for GA use; disability access; climate resilience; and decarbonisation

#### Southeast VFR Corridor


- Proposal by CASA, with Airservices Australia, to reclassify a portion of airspace southeast of Bankstown Airport to uncontrolled airspace and create a southeast corridor for all aircraft flying under Visual Flight Rules (VFR), up to 1500ft
- Proposal follows advocacy by AMG for new flight corridor
- Class G corridor proposed in response to the constrained nature of airspace in the Bankstown area and growth in air traffic in the Sydney Basin
  - Congestion will be exacerbated by the commencement of Western Sydney International Airport in 2026
- Bankstown Airport Southeast VFR Corridor is intended to:
  - Reduce airspace risks associated with the constrained nature of the Bankstown control zone and sustained growth in air traffic in the region;
  - Provide better access to Sydney flight training areas; and
  - Provide equitable and efficient access for airspace users, including general aviation.
- Early 2025: Additional community consultation on preferred corridor design




Proposed corridor highlighted in blue - inbound lane (L); outbound bound lane (R)

## WSI flight paths

- August 2024: Department releases proposal for night-time procedures for Western Sydney International Airport (WSI)
- Two proposals for reciprocal runway operations (RRO):
  - Removing flight path Runway 23 Departure Northeast Night (RRO) for jet aircraft and reallocating those aircraft to the flight path south of the airport
  - 2. RRO noise abatement procedures for aircraft travelling to north and west of the airport
- September 2024: Department community information and feedback sessions
  - No formal submission process
