### 2. Opening

- New Chair, Deborah Palmer (DP), opened the meeting by introducing herself and acknowledging and thanking previous Chair Brenton Burman.
- DP ran through agenda and invited questions.
- All attendees in person and online introduced themselves.

### 3. AMG presentations and updates

- DP and attendees welcomed.
- Recent appointment of Michael Noakes as AMG Enterprise Risk Manager is part of AMG's investment in additional risk and safety management. There will be ongoing risk and safety communications from AMG with a new program and brand, "Aeria Safe", anticipated to launch in a couple of months.

### Community events

- Acknowledgement of UNSW Aviation's recent onsite event celebrating the addition of two new Diamond aircraft to bolster their training fleet. An additional four aircraft will join the fleet in coming months.
- AMG sponsored the 14-kilometre run in the inaugural City of Canterbury Bankstown running festival held on 17 March 2025. AMG's Tom Smith and Peter Munro were among the participants.
- AMG is proud to again sponsor the annual Padstow Rotary Awards Night, to be held on Tuesday 25 March 2025. The awards night recognises the work and dedication of emergency services personnel, including operators at Bankstown Airport.
- AMG is again sponsoring the Anzac Day Dawn service to be held at Camden RSL in April 2025.
- AMG supported International Women's Day in several ways. AMG COO Amanda Majarres appeared on a panel at a Facility Management Association of Australia event about workplace challenges and opportunities for women and gave an interview to Pacific International about inspiring the next generation of women leaders.
- AMG 2024 Sustainability Report has been released.

#### Leasing opportunities

- There are currently several leasing opportunities at the a:
  - Lot 4B at 1 Kirby Place modern high-clearance warehouse
  - Site 611 at 65 Tower Road upgraded aircraft hangar and facilities.

#### Aircraft movements

- Movements are consistent with previous years at about 225,400 for calendar year 2024. Bankstown Airport is the fourth busiest airport in Australia.
- Flight schools, followed by emergency services, account for the largest proportion of movements.

#### Aviation safety

- An emergency exercise was run in November 2024 that simulated a collision between two aircraft, including staged injuries of passengers.
- Participants included Fire & Rescue NSW, NSW Ambulance and NSW Police.
- The exercise resulted in positive outcomes and showed that the airport is well prepared if this type of emergency were to take place. Minor learnings will be taken forward for future consideration.
- Automatic Weather Information Broadcast/ Service was installed in March 2025 and testing is underway. The service provides automated broadcasts of meteorological and operational conditions to improve safety and amenity.

#### Infrastructure works

AERIA = Bankstown Camden

- Tower/Link Road upgrade is largely complete. The upgrade has provided major connectivity and amenity improvements, including new parking bays, lighting, security, drainage works and a new shared footpath and cycleway that links to Council's existing network. People are already using the new paths, in support of active transport.
- Five substations are being upgraded across the airport to improve reliability. The works are expected to be completed by June 2025. Localised outages are anticipated and will be communicated in advance with airport operators.
- Resurfacing of Nancy Ellis Leebold Drive (near entry/exit with Milperra Rd), to improve road conditions and safety, were completed in March 2025.
- Stage 1 of the airport's major airfield upgrade (to taxiways) was completed in 2024. Stage 2 is planned for FY 2026 and will see the upgrade of all three airport runways. The works will be planned to minimise operational impacts and in consultation with airport operators. While operators can anticipate runway closures, this will mostly take place outside of typical operating hours. These works represent a significant investment by AMG in aviation infrastructure and services.

### Major Development Plans (MDPs)

The following two projects have been discussed in detail at previous meetings and an update was provided at this meeting:

- Aviation Hangar Project:
  - Two new hangar buildings to support up to 10 separate general aviation operations.
  - Public exhibition of the plans ended 3 February 2025. Thanks to everyone who provided submissions. All feedback was considered and documented in the final Draft MDP submitted to the Commonwealth Government for approval.
  - MDP is currently under consideration by the Minister for Infrastructure, Transport, Regional Development and Local Government, with a decision expected by mid-May 2025.
  - AMG will provide updates to stakeholders.

#### Birdwood Road Mixed-Use Project:

- Proposed development on vacant land next to the SUPA IGA Georges Hall, between Birdwood Rd and Link Rd, on the northern periphery of the airport.
- Proposal is to redevelop the vacant land which is a designated commercial site in the Bankstown Airport Master Plan 2019 – for community and business services, including a new childcare centre, shops, offices and medium-scale warehouses.
- MDP is on public exhibition for 60 business days, ending 6 June 2025. The plans and information about upcoming consultation events are on AMG's <u>website</u>. Hard copies of the plans are also on display in the airport terminal, AMG's offices and several local libraries. Copies of community information boards were made available to the CACG during the meeting and members were invited to ask questions and provide feedback.
- Newsletter about the proposal was distributed to almost 7000 homes in the local area.
- Future engagement and consultation opportunities include a community pop-up, community information session and airport customer briefing.
- CBC asked if public amenities were part of the plans. AMG responded that these were planned and undertook to provide more detailed information.
- CBC also noted resident concerns about the availability of off-street parking in the area and was supportive of the parking being provided as part of the proposal – including a new 100-space car park along Birdwood Rd.

#### Other developments

<u>Altitude Gateway (Kirby Place / Starkie Drive)</u>



- New childcare centre, shops, offices and warehouses.
- Works completed to date include earthmoving, concrete slabs, steel structure works, roofing and kerbs.
- o Landscaping and footpath works expected to be completed by May 2025.
- Realignment of Starkie Drive expected to be finished by October 2025.
- <u>Site 606 Miles Street (Aviation Microsite)</u>
  - 1900sqm site with prime hangar, office and lounge space.
  - Works anticipated between June and December 2025.

#### • Site 611 Tower Road

- Refurbishment of hangar and facility, to be available for lease.
- Works expected between May and June 2025.
- Lot 5C (Corner Tower Road & Henry Lawson Drive)
  - New petrol station, food outlets and car wash.
  - Works will be undertaken in two stages, with the first stage expected to be completed by July 2025.
- Building 62 (Airport Avenue)
  - Proposed demolition of building, in line with building condition and heritage reports.
  - Merit assessment, including public exhibition period, concluded December 2024. Thank you to everyone who provided feedback or submissions.
  - Proposed demolition pending approval by Airport Building Controller.
  - Proposal will enable delivery of new airside/landside facilities on the site to support general aviation.
- South Tower Road
  - Proposed development of new premium aviation and industrial estate on underutilised land at the southern end of Tower Road. Plans include new aircraft hangars to meet growing demand and flexible facilities to accommodate diverse operations.
  - Opportunity for current airport operators to relocate to new facilities.
  - Construction expected to commence in July 2025, with the facility available for lease in December 2026.
  - AMG to engage with airport operators on proposal and works.

#### Industry news

- Update on proposed Bankstown Airport Southeast VFR Corridor.
- CASA proposal to reduce safety risks and hazards for airport operators, amid increased airspace congestion and complexity related to the commencement of Western Sydney International Airport (WSI).
- Industry feedback included concerns that proposed corridor design could create safety risks.
- CASA is now redesigning the corridor to respond to these concerns. AMG expects the redesign will be for a oneway southbound corridor only.
- CASA/ ASA are expected to release the revised design for industry and community consultation and feedback in mid-2025.
- CBC asked if WSI will affect air traffic at Bankstown Airport. AMG responded that the commencement of WSI in 2026 and related airspace changes would increase airspace complexity, congestion and constraints for operators, particularly flight training schools. AMG is in ongoing discussions with the Department about ways to minimise operational, economic and safety impacts.
- CBC noted that the cost impost on flight schools had been previously raised with Council. The negative impacts on pilot training, amid a global pilot shortage, must be raised with the Department, ASA and CASA. AMG welcomed CBC and aviation industry support in advocating for Bankstown Airport operators. CBC confirmed its support.
- 4. Airservices Australia presentation and update

- Air traffic movements: Bankstown Airport air traffic movements between December 2024 and February 2025 remained relatively stable, with only a dip in activity over the Christmas period.
- Between October 2024 and February 2025, there were:
  - 102 aircraft noise complainants 190 contacts and 79 new complainants
  - Complainants lived across 70 different suburbs, with Panania (10), followed by Condell Park and Springwood (both 5) most represented
  - Most complaints related to essential nighttime movements by emergency services, which are outside ASA's remit.
- ASA has produced a factsheet about emergency services to address related complaints and this has proven quite effective. The factsheet has been previously provided to CACG members.
- ASA is going out to market to renew its noise reporting services and is interested in any suggestions to improve its data.
- AMG noted that the timing of emergency services flights responds to need and may have unavoidable impacts on residents at night.
- Separately, AMG anticipates an increase in noise complaints when WSI opens in 2026, because of the increase in aircraft movements across the Sydney Basin and related flight path changes for Bankstown Airport and Sydney Airport.

### 5. AMG 2024 Sustainability Report and initiatives

- AMG has identified three pillars to achieve sustainability: Environmental Stewardship; Community and Wellbeing; and Resilient Operations.
- AMG's vision is: "To be a leader in general aviation airports, commercial precincts and in our community. We will achieve this by committing to net zero by 2030, being aware of our impacts, and engaging in an ethical and responsible way."
- CBC asked how AMG was managing emissions related to aircraft fuel. AMG noted advancements in Sustainable Aviation Fuel (SAF) and the development of electric- and hydrogen-powered aircraft at Bankstown Airport, including by its customer AMSL Aero. AMG noted that SAF is currently not produced in sufficient volumes in Australia and is very costly for aircraft operators. AMG is proud to note that Bankstown Airport operator Airlink recently used SAF for some flights. AMG also noted that Bankstown Airport was the first airport in Australia to use hydrogen as aviation fuel.
- AMG provided a further breakdown on its three pillars and explained how they are contributing at a local level to the United Nations Sustainable Development Goals.
- AMG's notable sustainability achievements in 2024 include: cleaner supply chains; the planting of more than 100 native trees at Camden airport; and the development of a vision for AMG's first Reflect Reconciliation Action Plan (which will be delivered in 2025).
- AMG is also a committed environmental steward, including caring for a large wombat population at Camden Airport and working with a local landcare group to preserve Bankstown Airport's unique native flora.
- AMG invites CACG members to reach out with their stories and any opportunities to collaborate on sustainability initiatives.

#### 6. Updates from local council and state and federal MPs

- CBC raised traffic and parking issues around Georges River Grammar, at school drop-off and pick-up times. AMG advised they are working with the school and residents to try to reduce such impacts. The proposed design for the Birdwood Road Mixed-Use Project MDP would introduce another 200 car and vehicle spaces including a 100-space car park on Birdwood Road easing traffic and parking issues. AMG noted parking is a concern that is often raised by residents. However, Georges River Grammar is the only local school on the airport precinct and AMG cannot control what happens at other surrounding schools.
- CBC raised the impact of flight path changes related to the commencement of WSI. AMG responded that Bankstown Airport flight schools would need to fly further to do training, making their operations more expensive for students.

**AERIA =** Bankstown **Camden** Airport

- Several CACG members including Councillor Wendy Lindsy and Councillor Saud Abu-Samen asked AMG how best to advocate for airport operators, including letters of support. AMG said it is advocating for a range of measures, on behalf of its operators, such as compensation and investment in facilities and infrastructure to offset impacts and support general aviation. AMG will provide the CACG with a summary of these measures.
- CBC stated the proposed developments at Bankstown Airport were a great initiative, noting the need for more childcare facilities in the area. CBC also supports the idea of government investment and financial support and will support AMG in any such proposal.
- CBC asked what is being done to address aircraft noise complaints. AMG advised that ASA is the official body with the authority to investigate and report on aircraft noise complaints and movements. However, AMG encouraged residents to approach AMG with any such complaints, including dates and times of specific aircraft movements. AMG is committed to working with airport operators to address and reduce aircraft noise concerns, where possible. Most people in the area appreciate that the airport has been here a long time.
- AMG works closely with their operators to minimise noise, including through the airport's Fly Neighbourly program.
- It was noted AMG also works closely with operators to minimise noise for students at Georges River Grammar during exam times.
- CBC thanked AMG for supporting a healthy and active community through its sponsorship of the recent running festival. CBC is launching a "visit local" campaign to promote the City of Canterbury Bankstown as a tourism destination. CBC invites airport tenants and partners to reach out and share their stories.
- CBC noted there are three development applications within the LGA that will be assessed by the NSW Government as state significant developments, because they are each over \$60 million AMG can expect a referral from the NSW Government in relation to these applications to provide comment.

### 7. Other attendee updates and general business

• Padstow Rotary reported on the upcoming awards night on 25 March 2025 to recognise local emergency services. Awards will be presented to representatives of emergency services, including airport operators, in recognition of their contribution to the community. These awards have been held for several years now.

### 8. Member survey

- A survey will be distributed seeking member feedback about CACG meeting's format, length and topics, including whether future meetings could have a specific focus or "deep dive" on topics, such as SAF. The aim is to make meetings as interesting and valuable as possible to members. Members can also contact the Chair directly with questions or feedback.
- AMG is also committed to making the meeting as engaging and efficient as possible. A later start time, for example, may work better for members. A question on this will be included in the survey.

### 9. Western Sydney International Airport – Final Environmental Impact Statement

- Department provided an update on WSI flight paths and Final Environmental Impact Statement (EIS), released on 6 November 2024.
- In response to consultation undertaken in August 2024, the Final EIS includes five changes to the previous EIS. These changes do not impact Bankstown Airport.
- 8477 submissions were received in relation to the Draft EIS, including from individuals, operators and agencies. Each submission was considered by the Department. This resulted in a final 50 issues being taken forward by the design team and informing the five adopted changes.
- Next steps: Advice from the Commonwealth Minister for the Environment is currently being considered. The Minister for Infrastructure, Transport, Regional Development and Local Government will then decide whether to approve the flight paths. Detailed design will take place in 2025. ASA will undertake further community and industry consultation in mid-2025 and the flight paths will be implemented in late 2026. AMG noted that while

WSA is expected to open in late 2026, related airspace changes that will impact Bankstown Airport will be introduced in mid-2026.

- Ongoing consultation by the Department will be held with operators at Bankstown and Camden airports on the changes proposed to their respective airspaces.
- DP noted earlier conversations in this CACG meeting around the impacts of airspace changes on flight training operations at Bankstown Airport, including increased financial costs, particularly for smaller operators. DP advised that there was a lot of interest from members. Department responded that they recognised the impacts on airport operators and that the changes are significant. The EIS has put forward the potential impacts, including an economic assessment of financial impacts on flight schools. The Department's position is that this is a matter for operators. CASA is leading the work on the proposed Bankstown Airport Southeast VFR Corridor and may be able to address some of the issues outside ASA's remit.
- CBC asked if there were plans to compensate Bankstown Airport operators through, for example, investment by the Federal Government in a shared development that would earn income to offset costs. The Department responded that compensation was not Government policy at the present time. However, there is a commitment within the Final EIS for Government to continue to consult with airport operators and users about the changes and related mitigation measures.
- AMG commented that mitigation might also include government investment or financial incentives to support facilities and infrastructure upgrades at Bankstown and Camden airports, to support general aviation in the Sydney Basin. The Department responded that they are aware of such proposals and that AMG can put this forward to the Federal Government as part of a coordinated approach. The Department reiterated that Federal Government investment/ compensation is not current policy.
- CBC raised the recent security issue at Avalon Airport. AMG responded that Bankstown Airport is a general aviation airport and that consideration of security measures in relation to the incident concerned commercial passenger airports. However, AMG is currently undertaking a security review and identifying any lessons it might learn from the incident.

### 10. Actions arising

Department's update about the implementation of the National Airports Safeguarding Framework was carried over.

#### 11. Next meeting

Next meeting of the Bankstown Airport CACG to be held on Monday 30 June 2025. Start time TBC.







## Bankstown Airport Southeast VFR Corridor

- CASA proposal to create a southeast VFR corridor for aircraft at Bankstown Airport to reduce safety risks and hazards
  - Amid increased airspace congestion and complexity related to Western Sydney International Airport
- Industry feedback included safety concerns about "lowlevel nature of the corridor, the risk of mid-air collision and the likelihood of airspace incursions"

- CASA redesigning corridor to reduce such safety concerns
- AMG expects redesign will be for a one-way southbound corridor only
- Mid-2025: CASA/Airservices Australia industry and community consultation on redesign.
